

Lolworth Parish Meeting's Social Media and Electronic Communication Policy.

The use of digital and social media and electronic communication enables the Clerk of Lolworth Parish Meeting to interact in a way that improves the communications both within the Parish Meeting and between the Parish Meeting and the people, businesses and agencies it works with and serves.

The Parish Meeting has a website and uses email to communicate. It also uses the Lolworth Community WhatsApp group. The Parish Meeting will always try to use the most effective channel for its communications. Over time the Parish Meeting may add to the channels of communication that it uses as it seeks to improve and expand the services it delivers. When these changes occur this Policy will be updated to reflect the new arrangements.

The Parish Meeting website and the Lolworth Community WhatsApp Group provide information and updates regarding activities and opportunities within our Parish and promote our community positively.

Communications from the Parish Meeting will meet the following criteria:

- Be civil, tasteful and relevant;
- Not contain content that is knowingly unlawful, libellous, harassing, defamatory, abusive, threatening, harmful, obscene, profane, sexually oriented or racially offensive;
- Not contain content knowingly copied from elsewhere, for which we do not own the copyright;
- Not contain any personal information.
- If it is official Parish Meeting business it will be moderated by either the Chair/Vice Chair of the Parish Meeting or the Clerk to the Parish Meeting;
- Social media will not be used for the dissemination of any political advertising.

In order to ensure that all discussions on the Parish Meeting page are productive, respectful and consistent with the Parish Meeting's aims and objectives, we ask you to follow these guidelines:

- Be considerate and respectful of others. Vulgarity, threats or abuse of language will not be tolerated.
- Differing opinions and discussion of diverse ideas are encouraged, but personal attacks on anyone, including the Parish Meeting officers or volunteers, will not be permitted.
- Share freely and be generous with official Parish Meeting posts, but be aware of copyright laws; be accurate and give credit where credit is due.
- Stay on topic.

The site is not monitored 24/7 and we will not always be able to reply individually to all messages or comments received. However, we will endeavour to ensure that any emerging themes or helpful suggestions are passed to the relevant people or authorities. Please do not include personal/private information in your social media posts to us.

Sending a message/post via Facebook or Twitter will not be considered as contacting the Parish Meeting for official purposes and we will not be obliged to monitor or respond to requests for information through these channels. Instead, please make direct contact with the Parish Meeting's Clerk and/or Chair or Vice – Chair by emailing.

We retain the right to remove comments or content that includes:

- Obscene or racist content
- Personal attacks, insults, or threatening language
- Potentially libellous statements.
- Plagiarised material; any material in violation of any laws, including copyright
- Private, personal information published without consent
- Information or links unrelated to the content of the forum
- Commercial promotions or spam
- A breach of a Parish Meeting policy or the law

The Parish Meeting's response to any communication received not meeting the above criteria will be to either ignore, inform the sender of our policy or send a brief response as appropriate. This will be at the Parish Meeting's discretion based on the message received, given our limited resources available

Parish Meeting Website.

Where necessary, we may direct those contacting us to our website to see the required information, or we may forward their question to our Chair, Vice-Chair or Clerk for consideration and response. We may not respond to every comment we receive particularly if we are experiencing a heavy workload.

The Parish Meeting may, at its discretion, allow and enable approved local groups to have and maintain a presence on its website for the purpose of presenting information about the group's activities. The local group will be responsible for maintaining the content and ensuring that it meets the Parish Meeting's rules and expectation for the web site. The Parish Meeting reserves the right to remove any or all of a local group's information from the web site if it considers that the content does not meet the Parish Meeting's rules and expectation for its website. Where content on the website is maintained by a local group it should be clearly marked that such content is not the direct responsibility of the Parish Meeting.

Parish Meeting email.

The email address of the Parish Meeting is the email address of the Clerk (clerk@lolworthparishmeeting.gov.uk). In due course this will be updated to a .org address.

The email account is monitored daily, and we aim to reply to all questions sent as soon as we can. An 'out of office' message will be used when appropriate.

The Clerk is responsible for dealing with email received and passing on any relevant mail to the Chair, Vice-chair or external agencies for information and/or action. All communications on behalf of the Parish Meeting will usually come from the Clerk, and/or otherwise will always be copied to the Clerk.

The Chair and Vice-Chair are at liberty to communicate directly with parishioners in relation to their own personal views, with, if appropriate, copy to the Clerk. NB any emails copied to the Clerk become official and will be subject to The Freedom of Information Act.

These procedures will ensure that a complete and proper record of all correspondence is kept.

Do not forward personal information to other people or groups outside of the Parish Meeting, this includes names, addresses, email, IP addresses and cookie identifiers.

SMS (texting).

Parish Meeting Officers may use SMS as a convenient way to communicate at times. All are reminded that this policy also applies to such messages.

Video Conferencing e.g. Skype.

If this medium is used to communicate please note that this policy also applies to the use of video conferencing.

Internal communication and access to information within the Parish Meeting.

The Parish Meeting is continually looking at ways to improve its working and the use of social media and electronic communications is a major factor in delivering improvement.

Parish Meeting Officers are expected to abide by the Data Protection Act in all their work on behalf of the Parish Meeting.

As more and more information becomes available at the press of a button, it is vital that all information is treated sensitively and securely. Parish Meeting Officers are expected to maintain an awareness of the confidentiality of information that they have access to and not to share confidential information with anyone.
